Please make sure to **update** them so they will reflect the expanded **two week** window for pre-registration scans. You can use a permanent marker to cover the previous requirement and to add the new **two weeks**.
- Upload discharge summaries **in Rave** within 14 days of discharge.



Potential Participants Concerned with Burden of Calls

If you have a patient who would like to participate on the study but is concerned with the burden of the follow-up calls, discuss with them the options they have for the calls and the importance of the hospitalization data. Specifically:

- Patients may designate a representative or alternate contact to respond to the calls on their behalf.
- The first priority for data collection is for the hospitalization information on the weekly calls from the site. If the patient and/or their representative want only to give that information, the call can be limited to that.
- Patients may refuse to complete one or more questionnaires during the call.
- Patients and/or their representative may refuse to complete a dietary recall.
- Patients who wish to stop all future calls may request this and allow their hospitalization data be gathered from their hospital records (this is passive follow-up – and requires submission of the S1316 Off Protocol form).

Coordinators Call
